













Overview

In the U.S., an estimated 1.5 million adults have rheumatoid arthritis (RA), about 1 percent of the population. Evidence shows that people with RA experience loss in function in every domain of human activity including work, leisure, and social relations. The focus of treatment for arthritis is to control pain, minimize joint damage, and optimize function and quality of life.

Purpose

This conference will provide updated information to professionals on evidence-based, best practices in caring for people with rheumatoid arthritis. The program addresses interprofessional team work in the context of health reform, current diagnostics and treatments, and introduces self-management education for chronic disease. Research shows that self-management education increases self-efficacy for symptom management and behavior change, engaging the client in disease management along with their healthcare team.

The program will be offered live at the Gutenshohn Clinic in Kirksville, Missouri and also offered as a live webinar. **Be sure to designate your preference on the registration form!** (Webinar attendees will be required to complete a post-test with 70 percent accuracy to receive continuing education credit.)
